**WAKE COUNTY**

This AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR DEERFIELD SQUARE is made as of this 9th day of January, 2006, by the undersigned, representing a majority of the Owners in Deerfield Square and within Deerfield Square Homeowners Association, Inc., a North Carolina nonprofit corporation (hereinafter, the "Association").

W I T N E S S E T H:

WHEREAS, Deerfield Square Associates, Inc., a North Carolina corporation, recorded a Declaration of Covenants, Conditions and Restrictions for Deerfield Square on January 2, 1980 in Book 2799, Page 71, of the Wake County Registry (hereinafter, also, the "Declaration"); and

WHEREAS, the Declaration provided in Article X thereof that the covenants set forth in the Declaration could be amended in whole or in part upon the recording of an instrument signed by not less than the Owners of seventy-five percent (75%) of the lots in Deerfield Square; and

WHEREAS, there are a total of twenty-seven (27) lots within Deerfield Square and the Owners of twenty-one (21) of said lots have consented to the proposed Amendment herein by signing this instrument; and

WHEREAS, the Owners of more than seventy-five percent (75%) of the lots in Deerfield Square desire to amend the Declaration as provided in Article X of the Declaration by written consent as herein below set forth in "Exhibit A," attached hereto and incorporated by reference herein;

NOW, THEREFORE, the undersigned do hereby declare that the Declaration is hereby amended as follows:

1. Article II of the Declaration is amended by rewriting Section 4 thereof to read as follows:

“Section 4. Parking Rights: Ownership of each single family attached townhouse lot shall entitle the owner or owners thereof to the use of not more than two (2) automobile parking spaces, which shall be as near and convenient to said lot as reasonably possible, together with the right of ingress and egress in and upon said parking lot. The Association shall permanently assign one of said parking spaces for each townhouse lot as near the dwelling to which it is assigned as is reasonably possible. The Association may prohibit or regulate the parking of boats, trailers, commercial vehicles of all kinds and other such items on the common area. No boats or trailers shall be parked within the right-of-way of any public street in or adjacent to Deerfield Square.

The Board of Directors shall have the right and authority to make, amend, implement and enforce such parking rules and regulations as it deems necessary and appropriate, and shall have the right and authority to enforce the same. Furthermore, the Association shall have the right and authority to have towed any vehicle parked or maintained in violation of these or subsequently adopted parking rules and regulations, the cost of which towing and storage shall be the responsibility of the owner of the lot to which vehicle is registered.”

2. Pursuant to Article X of the Declaration, this Amendment shall be effective upon recordation in the Wake County Public Registry.

3. Except as amended hereinabove, the remaining provisions of the Declaration, as previously amended, are hereby confirmed and acknowledged in every respect.

4. The Board of Directors of the Association has reasonably assured itself that the foregoing Amendment has been executed by the Owners of the required number of lots and has attached to this Amendment a certification as to its validity, which certification is attached hereto, marked "Exhibit B," and incorporated by reference herein.

5. The foregoing Amendment to the Declaration was submitted to the office of the City Attorney on January 10, 2006. Approval has not been made within thirty (30) days after being submitted to the City Attorney, and therefore said Amendment is deemed approved and may be recorded forthwith in accordance with Article X, Section 10 of the Declaration.
